**Subject:** Child And Adult Care Food Program Reimbursement Rates

This notice announces the annual adjustments to the national average payment rates for meals served in child care centers, outside-school-hours care centers, at-risk afterschool care centers and adult day care centers. The payment rates for meals served in day care homes, and the administrative reimbursement rates for sponsors of day care homes are also listed. The following rates of reimbursement are maximum rates. These rates, when multiplied by the percent of applications (free, reduced, and denied), are used by the state agency to calculate your reimbursement.
